**Firefighting Medical Supplies****Action:**

- A. Approve a unit price contract to the lowest responsive bidder Concordance Healthcare Solutions LLC for the purchase of firefighting medical supplies for a term of three years, and**
- B. Authorize the City Manager to renew the contract for up to two, one-year terms with possible price adjustments and to amend the contract consistent with the purpose for which the contract was approved.**

Damian Owens, Fire**Explanation**

- Medical Supplies are carried on fire trucks to allow firefighters to provide first aid and basic life support. These supplies include oxygen masks, trauma bags, catheters, bandages, airflow monitors, tubes, and stethoscopes as well as other medical supplies.
- On October 8, 2018, the City issued an Invitation to Bid; eight bids were received.
- Concordance Healthcare Solutions LLC was selected as the lowest responsive, responsible bidder.
- The City issued the Invitation to Bid on behalf of the Charlotte Cooperative Purchasing Alliance (CCPA). CCPA is a cooperative purchasing program established by City Procurement with the specific purpose of reducing procurement costs by leveraging aggregate purchasing volume to receive better pricing.
- The estimated annual expenditures are \$500,000.

**Charlotte Business INclusion**

No subcontracting goal was established because there are no subcontracting opportunities (Part C: Section 2.1(a) of the Charlotte Business INclusion Policy).

**THIRD AMENDMENT TO THE AGREEMENT TO PROVIDE  
MEDICAL SUPPLIES**

**THIS THIRD AMENDMENT TO THE AGREEMENT TO PROVIDE MEDICAL SUPPLIES** (this "Third Amendment") is made and entered into this 29th of October 2020, by and between Bound Tree Medical LLC, an Ohio corporation doing business in North Carolina (the "Company"), and the City of Charlotte, a North Carolina municipal corporation (the "City").

**Statement of Background and Intent**

- A. The City of Charlotte and the Company entered into an Agreement for Medical Supplies dated December 10, 2018 (the "Contract") pursuant to which the Company agreed to provide Medical Supplies for the City of Charlotte.
- B. The parties amended the Contract to consent to change of control of the Company by acquisition on July 15, 2019 and to incorporate Exhibit A and certain other changes.
- C. The parties amended the Contract to incorporate unit price increases on Exhibit A on August 31, 2020.
- D. The parties now desire to amend the Contract to incorporate additional unit price increases on Exhibit A.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereby agree to the following:

**AGREEMENT**


- 1. The terms of the Contract are restated by and incorporated into this Third Amendment by reference.
- 2. Defined terms used in this Third Amendment shall have the same meaning as are assigned to such terms in the Contract.
- 3. This Third Amendment incorporates unit price increases on Exhibit A - Form Five Price Sheet, Items 116 and 127 from Nine Dollars and Eighty-Two cents (\$9.82) per box to Twelve Dollars and Eighty cents (\$12.80) per box, Item 119 from Ten Dollars and Thirty-Eight cents (\$10.38) per box to Twelve Dollars and Eighty cents (\$12.80) per box, Items 118, 121, 125 and 128 from Nine Dollars and Thirty-Nine cents (\$9.39) per box to Nine Dollars and Eighty-Nine cents (\$9.89) per box, Item 122 from Eight Dollars and Seventeen cents (\$8.17) per box to Twelve Dollars and Eighty-Five cents (\$12.95) per box, Items 117, 120 and 124 from Fifty-Four Dollars and Fifty cents (\$54.50) per case to Seventy-Six Dollars and Thirty-Six cents (\$76.36) per case and Items 129, 130 and 131 from Seven Dollars and Eighty cents (\$7.80) per box to Ten Dollars and Seventy-Two cents (\$10.72) per box due to escalation in material costs.
- 4. Except to the extent specifically provided above, this amendment shall not be interpreted or construed as waiving any rights, obligations, remedies, or claims the parties may otherwise have under the Contract.
- 5. In all other respects and except as modified herein, the terms of the Contract shall remain in force and effect.
