FIFTH AMENDMENT TO THE AGREEMENT TO PROVIDE INTERCEPTOR AND MISCELLANEOUS VEHICLES

THIS FIFTH AMENDMENT TO THE AGREEMENT TO PROVIDE INTERCEPTOR AND MISCELLANEOUS VEHICLES (this "Fifth Amendment") is made and entered into this 27 of November 2023, by and between Carthage F LLC DBA Cooper Ford, a corporation doing business in North Carolina (the "Company"), and the City of Charlotte, a North Carolina municipal corporation (the "City").

Statement of Background and Intent

- A. The City of Charlotte and the Company entered into an Agreement for Interceptor and Miscellaneous Vehicles dated July 22, 2019 (the "Contract") pursuant to which the Company agreed to provide Interceptor and Miscellaneous Vehicles for the City of Charlotte.
- B. The parties amended the Contract on July 22, 2020, to extend the Term of the Contract by the first of four (4) one-year renewal terms and to incorporate certain other changes.
- C. The parties amended the Contract on July 22, 2021, to extend the Term of the Contract by the second of four (4) one-year renewals.
- D. The parties amended on July 22, 2022, the Contract to extend the Term of the Contract by the third of four (4) one-year renewal terms and make adjustments to unit pricing based on model year price changes.
- E. The parties amended the Contract to extend the Term of the Contract by the Fourth of Four (4) one-year renewal terms.
- F. The parties now desire to amend the Contract to make adjustments to unit pricing on model and year price changes.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereby agree to the following:

AGREEMENT

- 1. The terms of the Contract are restated by and incorporated into this Fifth Amendment by reference.
- 2. Defined terms used in this Fifth Amendment shall have the same meaning as are assigned to such terms in the Contract.
- 3. This Fifth Amendment incorporates unit price revisions based on model and year price changes per the pricing sheet in Exhibit A.
- 4. Except to the extent specifically provided above, this amendment shall not be interpreted or construed as waiving any rights, obligations, remedies, or claims the parties may otherwise have under the Contract.
- 5. In all other respects and except as modified herein, the terms of the Contract shall remain in force and effect.
