SECOND AMENDMENT TO THE AGREEMENT TO PROVIDE CCPA CISCO PRODUCTS AND SERVICES

THIS SECOND AMENDMENT TO THE AGREEMENT TO PROVIDE CCPA CISCO PRODUCTS AND SERVICES (this "Second Amendment") is made and entered into this <u>5</u> of <u>February</u> 2024, by and between DISYS Soluctions Inc., a corporation doing business in North Carolina (the "Company"), and the City of Charlotte, a North Carolina municipal corporation (the "City").

Statement of Background and Intent

- A. The City of Charlotte and the Company entered into an Agreement for CCPA Cisco Products and Services dated March 12, 2019 (the "Contract") pursuant to which the Company agreed to provide CCPA Cisco Products and Services for the City of Charlotte.
- B. The parties amended the Contract to update the Price Schedule and to incorporate certain other changes.
- C. The parties now desire to amend the Contract to [extend the Term of the Contract by the first of two (2) oneyear renewal terms and to incorporate certain other changes.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereby agree to the following:

AGREEMENT

- 1. The terms of the Contract are restated by and incorporated into this Second Amendment by reference.
- 2. Defined terms used in this Second Amendment shall have the same meaning as are assigned to such terms in the Contract.
- 3. This Second Amendment extends the Term of the Contract by the first of two (2) one-year renewal terms to expire on March 11, 2025.
- 4. Except to the extent specifically provided above, this amendment shall not be interpreted or construed as waiving any rights, obligations, remedies, or claims the parties may otherwise have under the Contract.
- 5. In all other respects and except as modified herein, the terms of the Contract shall remain in force and effect.
